## **Amendments to be done in Article IV: Executive Committee (ExeCom) & SB Administration**

### **Revisions to be done:**

Original:

Sec. 1.2 The ExeCom selection can be done by January/February with effective from January 1st of each year

Amendment:

Sec. 1.2 The ExeCom selection can be done within 4 months with effective from January 1st of each year

## **Amendments to be done in Article X: Financial Support for Attending Events**

### **Revisions to be done:**

Sec. 1. Financial Support may be given to SB members/ ExeCom/Counselor/ Advisor/ Mentor to attend International and National events as per the following guidelines.

Original:

- I. For International events (Outside India), an amount greater than Rs. 7000 can be provided as support. The ExeCom should decide the amount after considering factors such as the event, geographical location and support from other sources. Counselor/Advisor can approve the amount

Amendment to be done:

- I. For IEEE International events (Outside India), an amount from Rs.15000 can be provided as support for 2 members per year. The ExeCom should decide the amount after considering factors such as the event, geographical location and support from other sources. Counselor/Advisor can approve the amount

## Sec. 2. Members Travel with IEEE Travel Grant

Original:

- I. As per the policy of IEEE all the expenses are reimbursed. SB can support full amount sanctioned by IEEE or Its affiliates upon request and such members should submit an affidavit that reimbursed amount will be pay back to SB after the travel with proper reporting. Also member should submit supporting documents to SB Execom regarding the same. Any issues in the reimbursement process the member should inform ExeCom/Counselor/Mentor for proper guidelines.
- II. Students/Counselor/Advisor/Mentor travelling abroad to attend IEEE Events with a travel grant / to receive SB award an addition \$100 (Hundred US Dollars) can be sanctioned for their local expenses.

Amendment:

- I. As per the policy of IEEE all the expenses are reimbursed. SB can support the full amount sanctioned by IEEE or its affiliates along with the additional amount required if the sanctioned amount is not sufficient (This additional amount will be a maximum of \$1000), upon request and such members should submit an affidavit that reimbursed amount will be payback to SB after the travel with proper reporting. Also, members should submit supporting documents to SB Execom regarding the same. For any issues in the reimbursement process, the member should inform ExeCom/Counselor/Mentor of the proper guideline.
- II. The Students/Counselor/Advisor/Mentor travelling abroad to attend IEEE Events with a travel grant to represent SB/ to receive SB award, an additional \$200 (Two Hundred US Dollars) can be sanctioned for their local expenses.

## **Sections to be added**

### Section 5: Financial Support for attending IEEE conferences and IEEE competitions

- I. Financial support shall be provided to two teams to meet the registration expenses for any IEEE paper presentation along with travel expenses subject to the approval of SB Counselor/Advisor.

- II. Support will be extended to two teams by covering registration fees for their participation in IEEE competitions along with travel expenses subject to the approval of SB Counselor/Advisor.

#### Section 6: Financial Support for Members of IEEE SB CEK

- I. Members who maintain consecutive two-year memberships will be eligible for a reimbursement of 50% of their membership fee. This support will extend to the first ten members who meet the eligibility criteria subject to the approval of SB Counselor/Advisor.
- II. Members undertaking their final year projects will have the opportunity to receive financial support of up to 10,000 INR per team, with provision for two teams subject to the approval of SB Counselor/Advisor.
- III. Members shall receive support through funding for internal MDI Projects. Students interested in submitting internal MDI proposals can present their comprehensive plans and budgets. Funding eligibility will be determined based on a thorough review and assessment of feasibility subject to the approval of SB Counselor/Advisor.
